Payment Security

We use the popular payment processing service “Square” for all payments. If the service provided is less than \$1200, there will be a 3% processing fee applied to the payment. Through Square you can pay with any type of credit card available. If you would prefer to avoid this fee for smaller orders you are free to pay via interact email transfer.

Invoices are issued via the Square platform, and all options are outlined on each invoice. Square is a secure payment processing service with several layers of encryption technology, complies with all security standards required by legislation and is fully PCI compliant, to keep your personal data secure.

Terms & Conditions for e-Design Services

- e-Design is an online decorating consultation service only. All recommendations are regarded as suggestions to improve the look of your space and not intended as formal construction design plans as we have not visually inspected or seen the structure or mechanical systems of your home.
- For the best results to be achieved, client agrees to provide full information regarding the client’s project requirements.
- Client agrees that they will receive up to 3 design revisions after the first design is delivered. (So, a total of 4 designs)
- Client agrees to additional fees of \$75.00/hour for alternate plans if requested. For example, version 1 and version 2 designs so the client may select from a choice of 2 design concepts.
- Client agrees to additional fees of \$85.00/hour for local in-person visits if requested. Local visits are defined as the North Simcoe, Ontario region. Visits outside of this area are subject to a fuel surcharge / travel fee.
- Approachable Interior Design will not be responsible for the means, methods or procedures of construction, fabrication, delivery & installation, or safety precautions in connection with the e-Design project; for the acts or omissions of the contractor, or any subcontractor, supplier or other person performing the work on the e-Design project; or, for any failure of them to meet any schedules or completion dates.
